- 6. Collegiate House Report- Past house treasurer missing funds-he has agreed to pay back \$5,000 (which is the amount that can be proved up to this point). He has paid \$1000 thus far, he is scheduled to pay \$1500 next month and the remaining \$2500 in May. The police report is still open and he has been advised that it will be reopened if he fails to pay the amounts in full and on time. There is still a question about the previous commanders and their participation in the crime. Chip recommends that the Chapter get this in writing or an email agreement.
